### SAFETY RULES OF THE WHANGAROA SPORT FISHING CLUB INC.

In the interest of safety, the Tournament Committee reserves the right to alter all times for the duration of the Tournament depending on the weather or sea conditions.

In the event of an emergency on the water, participants are to notify the Auckland Coastguard channel 84 or Whangaroa Radio on VHF channel 62

All boats must carry correct size Life Jackets for all passengers.

All participants agree to accept:

- a. To enter this Tournament at their own risk
- b. That boating and fishing involves a risk
- c. Not to hold Tournament organisers, Officials, Sponsors or any other person involved with the Tournament liable for any loss or injury to person or equipment incurred during the tournament.
- d. Notwithstanding any representations made, it shall be the responsibility of all participants to ensure that the provisions of all statutes, ordinances, regulations and by-laws related to (but not Limited) to boating & fishing are complied with.
- e. All participants agree to have read and understood the Tournament Rules.

My vessel is loaded within its limit and all equipment is securely stowed.
